Privacy policy

The 1998 Data Protection Act

According to the data protection act of 1998, all the information given to us by all customers is "personal information", including the uploaded files and e-mail addresses. We have to deal with the above personal information in accordance with the principles of the act. All personal information collected will be stored in the central database of our company. PB markets will act as a data manager and strictly abide by the responsibility of confidentiality.

Safety measures

This website adopts various preventive measures to protect users' information. When users submit some sensitive information through the website, information can be guaranteed no matter whether you are online or offline. Our website is a security mechanism using the SSL encryption protocol. The information submitted by all users will be translated into a password by 128 bit encryption technology. This encrypted measure prevents the information eavesdropper from seeing the information in the transmission directly to protect the security of the confidential information. Take Microsoft browser Internet Explorer as an example. When users browse the security web page, the encrypted image at the lower end of the web browser will be displayed as a lock. In addition to using SSL encryption protocol to protect sensitive information on line state, we also developed an internal code to protect offline information. Our employees are not allowed to view the user's information. Only employees who need to perform their duties are allowed to use such personal identification information, such as the bill clerk or the customer service representative. In addition, we will update our staff on safety and privacy guidelines. And we will notify all employees in every quarter and in the formulation of new policies, and remind them of the importance of privacy and protection of customer information. PB markets stores the client's personal information server in a secure place and locks up. Only authorized persons can obtain customer information.
